Notice is hereby given that the City of Romulus will hold a public hearing at **7:00 p.m.** on **Monday, September 18, 2023** for the purpose of considering the following:

1. **SLU-2023-001, 002, and 003/SPR-2022-013; Safeway Oil Service Center** requesting special land use approvals for a vehicle fueling station, car wash and drive-thru restaurant as part of a vehicle service center development. The property is owned by Wayne County Airport Authority and the 6.5-acre lease area is part of DP #80 053 99 0001 700, located on the west side of Middlebelt Road, south of Lucas Drive, and north of Hildebrandt. The property is zoned AP, Airport District.

DESCRIPTION OF PROPOSED LEASE AREA:

COMMENCING AT THE EAST 1/4 CORNER OF SECTION 14, THENCE ALONG THE EAST LINE OF SAID SECTION AND THE CENTERLINE OF MIDDLEBELT ROAD (162 FEET WIDE) N02°09'58"E 100.00 FEET; THENCE S87°50'02"W 372.00 FEET; THENCE N02°09'58"E 761.00 FEET; THENCE N87°50'02"E 372.00 FEET TO THE WEST LINE OF MIDDLEBELT ROAD (120 FEET WIDE); THENCE ALONG SAID LINE S02°09'58"W 761.00 FEET TO THE POINT OF BEGINNING. CONTAINING 6.50 ACRES OF LAND. ALL BEING PART OF PARCEL 80-053-99-0001-700.
